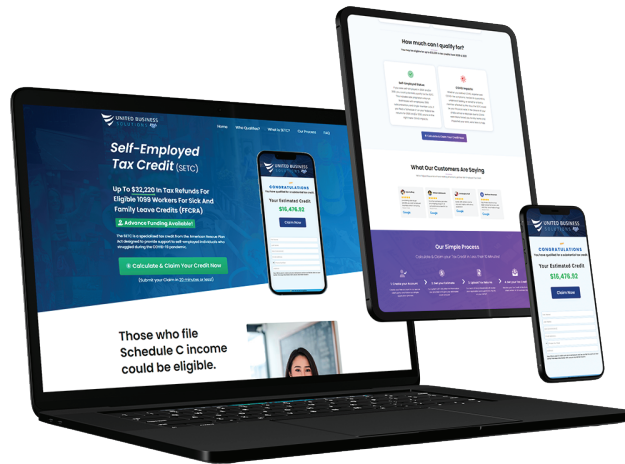
You had a child or children under the age of 18...

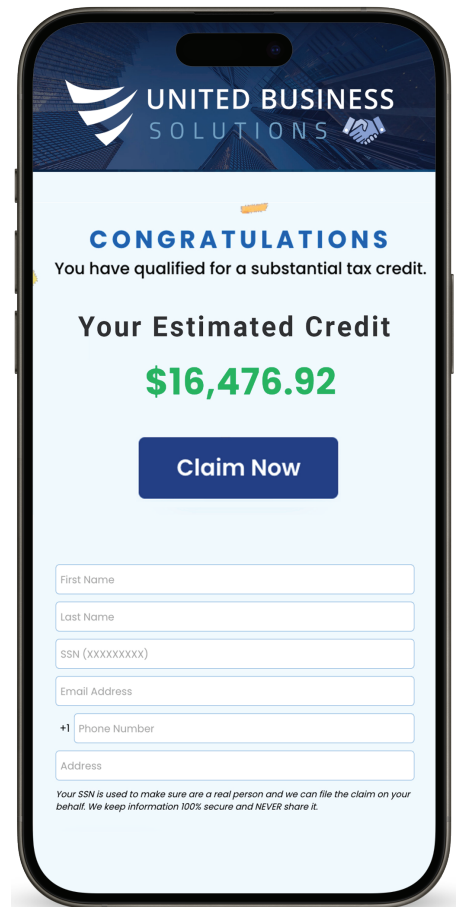

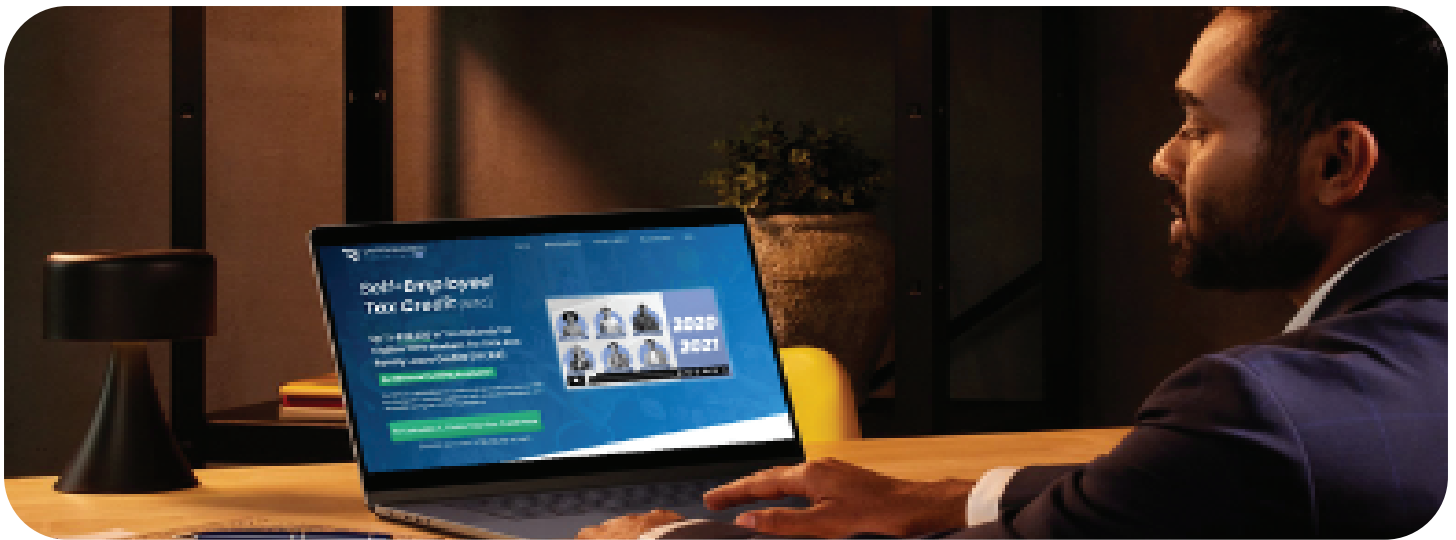
